



OFFICIAL RULES

Susan G. Komen® Facebook Fundraiser and ShopKomen Giveaway

Susan G. Komen would like to offer Susan G. Komen Facebook Fundraisers a chance to win one of ten gift giveaways. Each individual winner will have an opportunity to select one item of their choice from our [ShopKomen.com](https://www.shopkomen.com) shop before October 15, 2020.

NO PURCHASE NECESSARY: No purchase of any kind is necessary to enter or win. Making a purchase will not increase your chances of winning. Void where prohibited by law. Giveaway is subject to all applicable federal, state, and local laws.

ELIGIBILITY: Giveaway is open to legal residents of the fifty (50) United States and the District of Columbia who are 18 years of age or older. Employees of Susan G. Komen ("Sponsor"), are not eligible to enter or win.

HOW TO ENTER: Giveaway period is **September 21, 2020 through September 28, 2020 at 11:59 pm CT**. Complete the entry by creating a new Facebook Fundraiser at <https://www.facebook.com/fund/SusanGKomen/>. By creating a Facebook Fundraiser, you agree to allow Sponsor to contact you about breast cancer news, inspirational stories, updates on how to get involved, and more. Entries must be complete to be eligible. For alternative means of entry, mail a 3 inch by 5 inch notecard to Sponsor's address (Susan G. Komen, 13770 Noel Road, Suite 801889, Dallas, TX 75380), including full name, mailing address, and valid email address by September 28, 2020.

Limit of one entry or alternative entry per person throughout the giveaway period unless participant meets the following requirements: participants can receive one additional entry when they raise \$100 for their fundraiser and receive one more additional entry when they raise \$250 or more. No more than three total entries are allowed.

PRIZE DESCRIPTION: Each winner will receive the opportunity to select one item from the ShopKomen.com shop. Item must be selected on or before October 15, 2020.

WINNER SELECTION: All eligible entries submitted during the giveaway period will be entered into a drawing on September 29, 2020. Winner(s) will be randomly drawn no later than September 30, 2020. 10 prizes will be awarded. Odds of winning depend on the number of eligible entries received for the giveaway.

WINNER NOTIFICATION: Winners will be contacted through Facebook. To claim the prize, winners must follow the instructions provided in the notification and select a gift no later than 5 pm, October 15, 2020. Failure to timely respond will result in disqualification. It is within the discretion of Sponsor to select alternate winners if the prize is forfeited but is not required to do so.
